	<b>Policy Name: Smoke-Free Policy</b>

The purpose of this policy is to outline our centre's approach to maintaining a smoke free environment.

### Position Statement

At this centre we will prevent the detrimental effect of other people's **smoking or vaping** on the health of all adults and children here.

Smoking **and/or vaping** at the centre is not permitted inside or outside at any time and on any day.

We have signs that clearly state NO SMOKING and **NO VAPING** is permitted on the premises at any time on any day and will enforce this rule.

### Issue Outline

Smoking has been proven to be carcinogenic, both to the smoker and to those in close and regular proximity to the smoker. As social attitudes have changed, our centre has adopted a zero tolerance policy toward **smoking or vaping**.

### Detail

#### General:

- No one is allowed to smoke and/or **vape** on centre property, whether inside or outside of our premises.
- Cigarette butts are not to be discarded on centre property, as these can easily be picked up by children.
- Teachers are not permitted to **smoke or vape** on centre property. If teachers wish to smoke or vape **during breaks they must do so away from the centre premises where children can't see them** and must take steps to ensure their attire does not carry **any cigarette or vape** odour upon their return. Teachers who carry with them a **noticeable smoke or vape** odour will be asked to go home and change, with the time taken for this to be unpaid. If such action is required and it results in a failure for the centre to maintain its adult:child ratio or funding ratio, the matter will be regarded as a disciplinary issue.
- Appropriate "No Smoking" and "**No Vaping**" signage will be on display in the approach to and reception areas of the centre.

  - Smoking prohibited at schools and early childhood education and care centres:
  - **Vaping is prohibited at schools and early childhood education and care centres.**
  - The managers of school premises or premises to which subsection (4) applies (as per rationale) must take all reasonably practicable steps to ensure that:
    - No person smokes in any part of the premises (whether an internal area or an open area) at any time on any day; and
    - A notice stating that smoking within the premises is forbidden at all times is prominently displayed at or immediately inside:
      - (i) Every entrance to the premises; and
      - (ii) Every outer entrance to every building or enclosed area forming part of the premises.
